## 1. How We Use Your Data

- 1.1. NFCT and NFFC would like to use you/your child's images, video recordings, and voice recordings for promotional purposes. These may include:

  - 1.1.2. Digital content, including websites and social media platforms (e.g., Facebook, Instagram, Twitter); and/or

- 1.2. Footage may be edited, adapted, or combined with other content and will remain the property of NFCT and NFFC.

- 2.2. NFCT and NFFC take no responsibility for unauthorised use of images/recordings by third parties who have obtained them through lawful distribution.
- 2.3. This consent complies with the Data Protection Act 2018 and the UK General Data Protection Regulation (UK GDPR).

## 3. Withdrawing Consent

While NFCT and NFFC will make reasonable efforts to cease use in future publications, we cannot retract content already published or distributed.

## 4. Third-Party Use

## 5. Your Privacy
